### **INSPECTION FEES**

The Planning Board shall require inspection services for all major subdivisions which include road and/or utility line construction or for other subdivisions at the Planning Board's discretion. The cost of the inspection services shall be borne by the subdivider. The Planning Board may require the inspection services to be provided by either Town employees or agents or by an outside consulting, civil engineering firm of the Planning Board's choice.

# PROFESSIONAL REVIEW

The Board may require the subdivider to pay the cost of a professional review of various parts of the whole of the proposed subdivision upon such terms and conditions as the Board deems to be appropriate as provided by RSA 676:4-I(g). The Board shall select the professional(s).

### **OTHER FEES**

Any and all design engineering and review costs incurred by the municipality in excess of the above-mentioned fees shall be paid be the subdivider prior to any action by the Board to approve or disapprove the final plat.
